## Program Abstract

This program is for all clinicians and managers who perform, audit and/or are responsible for integrity of OASIS in a HHA. Beginners to OASIS, those who are struggling with OASIS, or those who need a refresher will all benefit from this seminar!

The intent that CMS has behind every M item is very important to understand in order to assign the correct scores for your patients. Many clinicians do not know the intent or how to apply it to their patients. We will go over the intent of each M item so that you are able to accurately assess each of your patients. We will also review in detail all of the challenging areas including wounds – the most complex area, heart failure, pain, medications ,etc. And we will review the importance of accurate OASIS in conjunction with ICD-10 coding.

Next, I will introduce you to the OBQI reports and show you how to analyze them so that you can use them to improve patient outcomes. OASIS scores are SO important as they affect the reimbursement and your patient outcomes.

Finally, on Day 2 we will have FUN going through multiple scenarios and see as a group what are the best ways to assess the patient and what scores we should use for OASIS.
