# **Program Abstract**

This program is for all clinicians and managers who perform, audit and/or are responsible for integrity of OASIS C2 in a HHA. Beginners to OASIS C2, those who are struggling with OASIS C2, or those who need a refresher will all benefit from this seminar!

The first hour will be spent on the very basics. Starting with the CMS concept behind OASIS and how it ties to the comprehensive assessment, we will then go over the OASIS C2 Data Set and review the OASIS conventions. Finally, we will show examples of intent and guidance in the OASIS manual, chapter 3.

Moving on, the OASIS C2 philosophy, including revisions and additions due to the Post Acute IMPACT act will be reviewed. OASIS C2 new M and GG items will be reviewed in detail, as well as all changes in OASIS C, along with the CMS manual intent and guidance to assess and score each.

The intent that CMS has behind every M item is very important to understand in order to assign the correct scores for your patients. Many clinicians do not know the intent or how to apply it to their patients. We will go over the intent of each M item so that you are able to accurately assess each of your patients. We will also review in detail all of the challenging areas including wounds – the most complex area, heart failure, pain, medications ,etc. And we will review the importance of accurate OASIS in conjunction with ICD-10 coding.

On day 2, scenarios will be done by the participants in groups in order to practice with the changes and the challenging items. Finally, we will introduce you to the CASPER OASIS outcome reports and explain how they reflect the patient and agency patient outcomes related to the all agencies in the country. CASPER and Home Health Compare will be reviewed. These outcomes not only give your agency their relation to the other agencies, but go toward the 5 Star Rating that your agency has. And also go towards the value based purchasing, which is now in the pilot in 9 states, but to be rolled out to entire country in next few years. OASIS scores are SO important as they affect the reimbursement and your patient outcomes.
