# **Program Abstract**

This program is for all clinicians and managers who perform, audit and/or are responsible for integrity of OASIS C2 in a home health agency. Beginners to OASIS C2, those who are struggling with OASIS C2, or those who need a refresher will all benefit from this seminar!

The first hour will be spent on the very basics. Starting with the CMS concept behind OASIS and how it ties to the comprehensive assessment, we will then go over the OASIS C2 Data Set and review the OASIS conventions. We will also show examples of intent and guidance in the OASIS manual, chapter 3.

Our first morning will continue with an initial review of how the M items become outcomes for the patient and the agency. 5 Star and Home Health Compare M items will be reviewed.

After lunch, we will begin taking a look at the intent of each M item so that you are able to accurately assess each of your patients. The intent that CMS has behind every M item is very important to understand in order to assign the correct scores for your patients. Many clinicians do not know the intent or how to apply it to their patients. We will also review in detail all of the challenging areas including wounds – the most complex area, heart failure, pain, medications ,etc. And we will review the importance of accurate OASIS in conjunction with ICD-10 coding.

On both days, scenarios will be done by the participants in groups in order to practice. This will help you to have practical experience.

During the afternoon of the second day, we will look at the CASPER outcome reports for an agency and discuss how OASIS leads to the outcomes for your agency. These outcomes not only give your agency their relation to other agencies, but go toward your agency's 5 Star Rating. In addition, they go toward value based purchasing, which is now in pilot in 9 states and to be rolled out to entire country in the next few years. OASIS scores are SO important as they affect reimbursement and your patient outcomes.

We will end with reviewing how to perform a comprehensive OASIS assessment with your patient. This is key to the integrity of the patient and your agency's outcomes! All clinicians have to do the assessment consistently in this manner for all OASIS timepoints, including discharge. So don't miss this crucial segment!
