OASIS-E FOR CLINICIANS AND REVIEWERS

## Program Abstract

This two-day comprehensive training includes all of the 27 new items for OASIS-E, OASIS items used for the PDGM functional score, the Quality of Patient Care Star rating and Value-Based Purchasing score calculation, items with wording/guidance updates for OASIS-E and key items used for quality and risk adjustment.

Teresa provides:

- explanation of the item guidance,
- assessment tips for accurate scoring,
- documentation requirements to support OASIS responses,
- home health scenarios for practice applying the guidance,
- discussion of the rationale for response selection,
- linking OASIS items to quality measures in the Home Health Quality Reporting Program

- ⇒ Home health agency clinicians that perform OASIS data collection, including field staff nurses and therapists.
- ⇒ Home health agency OASIS reviewers, quality improvement staff and educators.
